Fall Classic Weanling Pig Rules and Regulations

- Health regulations are listed on the opposite page.
- No clipping allowed in barns. Pigs should weigh between 40 and 70 lbs. (not required). It is recommended not to dock tails.
- All purebred weanling pigs who show in the purebred class must have a pedigree that accompanies each entry.
- Entries are open to all breeds and all crosses. Classes will be divided by breed, sex and the number exhibited.
- There is a limit of 6 weanling pigs (barrows, boars or gilts) per exhibitor.
- Weanling pig entries **CANNOT** and **WILL NOT** be accepted at the show.
